

Having been converted to condominiums over the years, Parkchester is experiencing something of a revitalization in recent years. The 12,000 units, completed in the early 1940s, received a top-to-bottom renovation that was completed in 2003, and has benefited from the financing of a consortium of the nation's largest nonprofit mortgage lender and three investors, which oversaw the renovation and created a special foundation to manage approximately 6,000 units at Parkchester. The remaining 6,000 units are independently owned and managed.

The community's buildings spread out from a park-like setting of shade trees, lawns and walking paths at the intersection of Metropolitan Ave. and Unionport Rd. There are also playgrounds, sitting areas and gardens, and many buildings are decorated with relief sculptures. Parkchester's current residents are diverse in age and ethnicity and include working class residents and young professionals, as well as a mix of immigrants.

Parkchester is also a wise investment because of its easy access to Manhattan, with its numerous transportation options, and its close proximity to desirable retail stores, movie theatres and religious institutions.

Macy's has leased retail space at Parkchester since 1910, and Starbucks, catering to urban professionals moving into the area, opened a Parkchester store in 2002.
